Summit View Activity Fields Standards for Usage

In order to promote a safe and healthy environment on the Summit View (SV) campus, user organizations agree to observe certain standards of behavior and maintenance on the property. During the period of approved use of the assigned field, the User Organization agrees to abide by the following conditions:

Summit View's campus will be open to the public from 9 a.m. to 9 p.m. Mondays through Saturdays, and from 7:30 a.m. to 6 p.m. on Sundays. Sports fields will **not** be scheduled for outside usage on Sundays or on certain designated holidays and scheduled church events. The campus shall be open and available for use by the general public or other groups which have been approved during times not assigned to the User Organization. **SV reserves the right to cancel public usage/events with 24-hour notice for unanticipated church events; i.e., funerals and other occasions in keeping with SV's mission.**

The main entry gate into the site will have a solar paneled, keypad lock system. The User Organization will be issued its relevant code(s) on signature of this Use Agreement.

Sports and field equipment may be stored on-site during and off-season at the designated locked storage facility. The User Organization will be responsible for securing a padlock and key system for its assigned section in the storage facility. SV assumes no responsibility for equipment stored on site.

Financial obligations of the User Organization at the SV campus will include the costs of one portable toilet at \$ _____ per month of usage and a dumpster at \$_____ monthly cost.

The User Organization also agrees to cover expenses for infield dragging, field lining, and other costs related to reasonable upkeep of the field. This includes repair of the mound and home plate areas and filling in of any holes. SV will provide a lining machine, specialized field rake(s); as well as bases, pitching rubbers and home plates. The User Organization shall be responsible for storing these items in the designated space. After each use and at the end of the season, the User Organization shall inspect the field and dugouts and ensure that they are left in a clean and presentable condition, with all trash and rubbish removed.

No alcoholic beverages will be allowed on the property. Profane language and inappropriate behavior detracts from the enjoyment of field activities and are expected to be controlled by the User/Applicant who assumes responsibility for conduct of participants and spectators on site. Vehicles (other than emergency) should remain on paved and designated parking/drive areas and should not be driven onto the field or pathways.

Each party to the agreement reserves the right of cancellation upon 90 days written notice to the other. Summit View reserves the right to enter into Use Agreements with other organizations in order to maximize use of fields. Such additional use shall not infringe on dates and times agreed upon with this User.
